Special Awards

1. Dedication Award

Background:

This award is presented to a registered member of Central Netball Club (Player/Official/Volunteer) to recognize his or her exemplary continuous commitment to Central Netball Club at a committee level.

Eligibility criteria:

The recipient must be a registered member of Central Netball Club, and an active member of the Central Netball Club Committee at the completion of the relevant netball season.

The recipient must have been an active member of the Central Netball Club Committee for a minimum of five (5) consecutive years.

Roles and titles are permitted to vary within this time.

It may be awarded to a member or members notwithstanding that the same member or members have received any other award in the same season.

The award may be presented to more than one member in any year.

Performance criteria:

To achieve this award, a nominee must have:

- Been an active member of Central Netball Club Committee for a minimum of five (5) Years.
- Displayed an exemplary commitment to Central Netball Club and its members through their role on the Committee.
- Demonstrated commitment and enthusiasm in adhering to Central Netball Clubs mission statement, to ensure the continuation of Central Netball Club
- Displayed initiative to improve Central Netball Club and its continuing development - this may include providing improvements to general Club processes, duties, policies and procedures.
- Not received remuneration for Committee work completed in the form of money, gifts or other from Central Netball Club or its members
- Maintained high attendance level to Committee meetings

Nominations

Nominations will be accepted from financial members of the Central Netball Club Committee.

Nominations must be in writing and address each of the criteria detailed above.

Successful Nominations

The award is not presented as a matter of course and will not be awarded in any year, to any member, if in the opinion of the Committee, the criteria are not met in all respects.



Final decision on award recipients will be determined by the current Central Netball Club Committee, as determined by majority voting. The President will have casting and deliberating rights.

Announcement:

The announcement and presentation of this award will be made at the annual presentation night.

2. Life Member Award

Background:

This award is presented to a registered member of Central Netball Club (Player/Official/Volunteer) to recognize his or her exemplary continuous commitment to Central Netball Club at a committee level.

Eligibility criteria:

The recipient must be a registered member of Central Netball Club, and an active member of the Central Netball Club Committee at the completion of the relevant netball season.

The recipient must have been an active member of the Central Netball Club Committee for a minimum of 10 consecutive years.

Roles and titles within the Committee are permitted to vary within this time.

It may be awarded to a member or members notwithstanding that the same member or members have received any other award in the same season.

The award may be presented to more than one member in any year.

Performance criteria:

To achieve this award, a nominee must have:

- Been an active member of Central Netball Club Committee for a minimum of 10 Years.
- Displayed an exemplary commitment to Central Netball Club and its members through their role on the Committee.
- Demonstrated commitment and enthusiasm in adhering to Central Netball Clubs mission statement, to ensure the continuation of Central Netball Club
- Displayed initiative to improve Central Netball Club and its continuing development - this may include providing improvements to general Club processes, duties, policies and procedures.
- Not received remuneration for Committee work completed in the form of money, gifts or other from Central Netball Club or its members
- Maintained high attendance level to Committee meetings

3. Senior Club Person

The recipient must be a current registered member of Central Netball Club over the age of 18 years old at the completion of the netball season, as a Player/Official/Volunteer, and have been a member of Central Netball Club for a consecutive two (2) years in atleast one of the aforementioned roles.

It may be awarded to a member or members notwithstanding that the same member or members have received any other award in the same season.

The award may be shared by more than one member in any year.

Performance criteria:

To achieve this award, a nominee must have:

- Been involved throughout the current season in at least two of the categories listed: Registered Player, Umpire, Coach, Manager or Committee member
- Embraced a positive, helpful and friendly attitude that benefits and promotes a safe playing culture at Central Netball Club. (As either a player, Coach, Umpire or other)
- Demonstrated significant contributions toward the club that go above regular duties of a Player, Umpire, Coach, Manager - Such as but not limited to
 - Filling in for teams when a short fall occurs
 - Filling in for coaches in a coach's absence
 - Assisting on club duty days in any capacity
 - Consistently assisting the coach on game day
 - Assisting in fundraising and club events internally and externally
 - Behavior on court and/or court side reflects a positive and encouraging attitude towards players, team mates, coaches, opposition and umpires

The recipient must be a current registered member of Central Netball Club under the age of 18 years old at the completion of the netball season, as a Player/Official/Volunteer, and have been a member of Central Netball Club for a consecutive two (2) years in atleast one of the aforementioned roles.

It may be awarded to a member or members notwithstanding that the same member or members have received any other award in the same season.

The award may be shared by more than one member in any year.

Performance criteria:

To achieve this award, a nominee must have:

- Been involved throughout the current season in at least two of the categories listed:
Registered Player, Umpire, Coach, Manager or Committee member
- Embraced a positive, helpful and friendly attitude that benefits and promotes a safe playing culture at Central Netball Club. (As either a player, Coach, Umpire or other)
- Demonstrated significant contributions toward the club that go above regular duties of a Player, Umpire, Coach, Manager - Such as but not limited to

The recipient must be a current registered member of Central Netball Club as a Player/Official/Volunteer, and have been a member of Central Netball Club for a consecutive two (2) years in at least one of the aforementioned roles.

It may be awarded to a member notwithstanding that the same member may have received any other award in the same season.



The award may be shared by more than one member in any year.

Performance criteria

To achieve this award, a nominee must have:

- Been involved throughout the current season as an Umpire for Central Netball Club for a minimum of five (5) games
- Embraced a positive, helpful and friendly attitude that benefits and promotes a safe playing culture at Central Netball Club on court.
- Developed umpiring credentials throughout the season. This may have been achieved by participating in Personal Development Programs - Such as but not limited to:
 - Participation in CNA Junior Development Program
 - Completion of Online Umpiring Course
 - Obtaining National C Badge
 - Obtaining National B Badge

Nominations

Nominations will be accepted from Committee members, team coaches, team managers or other adult members of Central Netball Club. The nominee may have received this award previously.

Nominations must be in writing and address each of the criteria detailed above.

Nomination Exemptions

The award will not be presented to the same recipient consecutive years, including if nominated and meeting criteria; and though Committee Members are eligible for nomination, this award will not be presented to a committee member of Central Netball Club concurrently following a year in which a committee member was the successful nomination.

Successful Nominations

The award is not presented as a matter of course and will not be awarded in any year, to any member, if in the opinion of the Committee, the criteria are not met in all respects.

Final decision on award recipients will be determined by the current Central Netball Club Committee, as determined by majority voting.

Announcement:

The announcement and presentation of this award will be made at the annual presentation night.



6. Coaching Award

Background:

This award is presented to a coach/Coaches to recognize his/her or their positive commitment to the development of athletes within Central Netball Club.

Eligibility criteria:

The recipient must have been in a coaching role with Central Netball Club for a minimum consecutive two (2) years.

It may be awarded to a member notwithstanding that the same member may have received any other award in the same season.

The award may be shared by more than one member in any year.

Performance criteria:

To achieve this award, a nominee must have:

- Demonstrated a high level of attendance and participation to training and games by being reliable and punctual
- Implemented a high level of organisational skills
- Adhered to child safety policies, and Central Netball Clubs Coaching Policies and procedures.
- Show enthusiasm taking on a teaching role and commitment to the development and improvement of individual players and the team
- Demonstrated efficient communication between parents, players and the Central Netball Club Committee
- Conducted themselves court side in a professional manner that is respectful to players, parents, opposition and umpires.
- Prioritise the well being of players
- Additionally, they may have taken on further teaching roles in the form of a Mentor to a junior coach

Nominations

Nominations will be accepted from Committee members, team coaches, team managers or other adult members of Central Netball Club. The nominee may have received this award previously.

Nominations must be in writing and address each of the criteria detailed above.

Nomination Exemptions

The award will not be presented to the same recipient consecutive years, including if nominated and meeting criteria; and though Committee Members are eligible for nomination, this award will not be presented to a committee member of Central Netball Club concurrently following a year in which a committee member was the successful nomination.



Successful Nominations

The award is not presented as a matter of course and will not be awarded in any year, to any member, if in the opinion of the Committee, the criteria are not met in all respects.

Final decision on award recipients will be determined by the current Central Netball Club Committee, as determined by majority voting.

7. Senior Club Person Recognition

Eligibility criteria:

The recipient must be a current registered member of Central Netball Club over the age of 18 years old at the completion of the netball season, as a Player/Official/Volunteer, and have been a member of Central Netball Club for a consecutive two (2) years in at least one of the aforementioned roles.

It may be awarded to a member or members notwithstanding that the same member or members have received any other award in the same season.

The award may be shared by more than one member in any year.

Performance criteria:

To achieve this award, a nominee must have:

- Been involved throughout the current season in at least two of the categories listed:
Registered Player, Umpire, Coach, Manager or Committee member
- Embraced a positive, helpful and friendly attitude that benefits and promotes a safe playing culture at Central Netball Club. (As either a player, Coach, Umpire or other)
- Demonstrated significant contributions toward the club that go above regular duties of a Player, Umpire, Coach, Manager - Such as but not limited to

- Been involved throughout the current season in at least two of the categories listed: Registered Player, Umpire, Coach, Manager or Committee member
- Embraced a positive, helpful and friendly attitude that benefits and promotes a safe playing culture at Central Netball Club. (As either a player, Coach, Umpire or other)

Eligibility criteria:



The recipient must be a current registered member of Central Netball Club as a Player/Official/Volunteer, and have been a member of Central Netball Club for a consecutive two (2) years in at least one of the aforementioned roles.

It may be awarded to a member notwithstanding that the same member may have received any other award in the same season.

The award may be shared by more than one member in any year.

Performance criteria

To achieve this award, a nominee must have:

- Been involved throughout the current season as an Umpire for Central Netball Club for a minimum of five (5) games
- Embraced a positive, helpful and friendly attitude that benefits and promotes a safe playing culture at Central Netball Club on court.
- Made a significant improvement within their umpiring ability throughout the season.

Nominations

Nominations will be accepted from Committee members, team coaches, team managers or other adult members of Central Netball Club. The nominee may have received this award previously.

Nominations must be in writing and address each of the criteria detailed above.

Generally, but not bound by, nominees for this award will regularly be Nominees for the Senior Club Person Award.

The award may be shared by more than one member in any year.

Performance criteria:

To achieve this award, a nominee must have:

- Demonstrated a high level of attendance and participation to training and games by being reliable and punctual
- Implemented a high level of organisational skills
- Adhered to child safety policies, and Central Netball Clubs Coaching Policies and procedures.
- Show enthusiasm taking on a teaching role and commitment to the development and improvement of individual players and the team
- Demonstrated efficient communication between parents, players and the Central Netball Club Committee
- Conducted themselves court side in a professional manner that is respectful to players, parents, opposition and umpires.
- Prioritise the well being of players

11. Sportsmanship Award

Background

This award is presented to one financial member of each registered team in a season for demonstrating outstanding sportsmanship.

Acknowledged and gifted at presentation day.

The recipient of the award is to be decided by each individual team's manager and/or coach, or voted on by the team players.

Eligibility criteria:

The recipient must be a registered member of Central Netball Club. It may be awarded to a member notwithstanding that the same member may have received any other award in the same season.

Performance criteria:

To achieve this award, an athlete must:

- Display good sportsmanship; including but not limited to displaying a positive and respectful attitude towards teammates, other competitors, managers, coaches and officials.
- May have displayed a sustained commitment to the team including a high level of attendance record at trainings and games;;
- Stand out as one who persistently strives for excellence in performance, commitment, represents strong team values and adheres to Central Netball Club policies;
